BACKGROUND

IAC was founded in 1987 to pursue and promote the conservation, development, and use of our agricultural resources for the betterment of our people. Tribal leaders, in a true expression of selfdetermination, identified and delegated their representation within the Intertribal Agriculture Council (IAC) Charter, comprising the voting membership that remains in existence today. This organizational leadership structure uniquely positions the IAC to inform policy and USDA programmatic implementation, simultaneously redefining and rebuilding our self-determined Tribal food systems.

ELIGIBILITY

All Federally recognized Tribes and Native Alaskan Tribes, as defined in the Self Determination Act, (PL93-638) with an interest in the management and development of Indian agricultural resources are eligible for general membership.

JOIN IAC'S GENERAL MEMBERSHIP AS A VOTING MEMBER TRIBE

A federally recognized Tribe may become a voting, general member of the Intertribal Agriculture Council by following these steps:

1. Submit Tribal Resolution (or something equivalent) to the IAC that expresses Tribe's intent to join the IAC as a General Member.

This document should comply with the requirements set by your Tribe's Governing Body and will remain in effect until officially withdrawn.

*A template resolution is included at the end of this packet that Tribes may use at their discretion. See Attachment 1, Template Tribal Resolution.

2. Designate Delegate to Represent Tribe's Interests on the IAC.

Formally Designate the Tribe's delegate to represent the Tribe' interests and vote on behalf of the Tribe at the Intertribal Agriculture Council's meetings.

3. Pay Membership Dues.

IAC will send an invoice once the Tribe submits a Tribal Resolution (or something equivalent), and designates a delegate. IAC can send an electronic invoice or assist your staff in sending invoice paperwork for payment processing via physical check to complete the payment of dues. Memberships runs from January 1st through December 31st annually.

* General Membership dues are set at \$200 annually.

GOOD STANDING

Tribal membership "in good standing" is based on three criteria:

- 1. Submitting written documentation confirming your Tribe's membership in the IAC. This should comply with your Tribe's Governing Body requirements and remain valid until officially withdrawn
- 2. Designating an official Tribal delegate to the Council
- 3. Paying annual dues for the current year

CAUCUS INFORMATION FOR IAC MEMBER TRIBES

TThe IAC caucuses are integral to our information sharing, policy development, and support structures, benefiing our Member Tribes and Indian Country as a whole.

Participation Benefits: As a voting member of the IAC, participating in your regional caucus allows you to influence the organization's annual priorities. Caucuses are regional meetings where Member Tribes discuss and propose their priority issues.

Caucus Participation Requirements:

1. **Registration:** To participate in a regional caucus, you must be registered as an IAC Member Tribe.

- 2. **Documentation:** Submit written documentation confirming your Tribe's membership in the IAC. This should comply with your Tribe's Governing Body requirements and remain valid until officially withdrawn.
- 3. **Designation of Representatives:** Formalize the designation of your Tribe's representative(s) as outlined. These representatives will act on behalf of their Tribe.
- **4.** Payment of Dues: Ensure that all dues are paid in full.

Caucus Process:

- Member Tribe delegates bring forward regional concerns or issues affecting agricultural success.
- Tribes in good standing can submit issues for consideration during the 2024 IAC Annual Conference regional caucus sessions.

Tribes may raise caucus issues via resolution, or by completing the online caucus form: bit.ly/IAC-caucusissue.

Final Reminder: Once approved, your Tribe's voting delegate can present actionable items at the Annual Membership Meeting.

ATTEND THE IAC ANNUAL MEMBERSHIP MEETING

The 2024 Annual Membership Meeting is scheduled for Thursday, December 12, 2024. This year's event will be held during the 2024 IAC Annual Conference at the Palms Casino Resort in Las Vegas, Nevada, on December 10-12, 2024. Registration for one [1] General Membership Tribal delegate will be waived to attend the Annual Conference, a savings valued at \$750.00!

REGIONAL CAUCUS PROTOCOL

- The Board Member or Alternate for your region is responsible for presiding over the Caucus meeting.
- The Board Member or Alternate for your region is responsible for presiding over the Caucus meeting.
- An IAC staff member will be in attendance to record the actions in our preferred format.
- Staff members may not offer issues for consideration, but may offer their perspective on issues raised, when asked to do so.
- It is generally accepted that all conference participants are invited to attend the meeting, and may raise issues for consideration.
- Issues may be offered for caucus consideration by registered conference participants from that region, however, if no duly appointed Member Tribe delegate(s) move to support the issue it will not be discussed, nor included in the caucus report offered to the membership.
- The Board Member from that region will present the regional caucus issues report to the General Membership at the annual Membership Meeting at the end of the Annual Conference, for consideration of adoption as IAC Policy for the year.

Issues not receiving consensus approval at the in-person caucus may be voted on in a manner as determined by the presiding officer, for reporting out to the Membership Meeting. A majority of the duly appointed Member Tribe delegates attending the caucus may approve an issue, or the caucus report in its entirety.

SAMPLE CAUCUS ISSUE

ISSUE: Less than 40 Tribes are able to utilize FRTEP due to the funding limitation to the program. Member Tribes request an increase in funding directly to their congressional representatives to \$10 M.

PROPOSED SOLUTION: IAC advocacy for 2023 Farm Bill will include mandatory funding for 100 FRTEP agents.
